Motion by Council Member Larsen, seconded by Council Member Resmondo to adjourn.

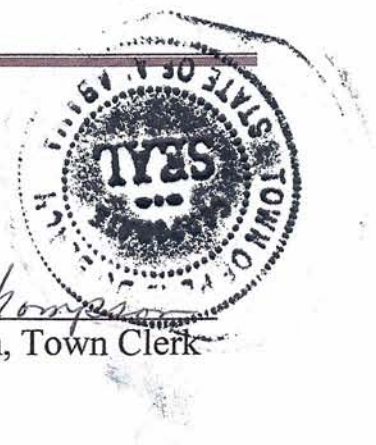
